Role	Transformational Impact	Technical Description	Gifts, Skills, & Character Traits
 Justice Champion	Your passion for biblical justice brings the Gospel Justice Center to life. As you answer God's call to seek justice and mobilize others to use their gifts to serve the vulnerable, you find joy and purpose.	Point of contact between the local Gospel Justice Center, host site, and AJ National Support Center. Coordinate volunteers in obtaining role-specific training. Unify the team through encouragement and prayer.	Leadership/Administration: Share vision while coordinating team ministry. Heart for justice, mercy and compassion. Good communicator.
 Attorney	You will find satisfaction in knowing that you are using a rare skill and resource (a law degree) to bring clarity to confusing circumstances for clients. Your efforts may seem small, but the impact on the clients is immediate and profound. Whatever you do for the least, you do for the Lord.	Limited scope/engagement services. 45-minute assessment of need to create a custom client Next Steps plan that empowers the client with a path toward resolution. May involve limited intervention short of representation.	Active license (many states allow retired or out-of-state counsel to serve). Heart of compassion. Desire to empower clients with guidance and counsel to do what they can to seek justice in their situation.
 Client Advocate	You derive joy from listening to the heart of others. As you lean into the circumstances of others, you experience joy from prayer, encouragement, and connecting clients with social/spiritual resources.	Meets with client following Attorney appointment. Confirms client's understanding of the Next Steps plan and discerns the need for additional resources. Prays and provides the hope of God's love.	Discernment and a shepherding heart. Able to listen well and offer wise counsel. Creative problem solver and resourceful. Comfortable praying. Social worker, counselor, or comparable heart.
 Community Advocate	You are a natural connector. You find joy in spreading the word about the Gospel Justice Center, gathering information, and connecting people and resources.	Visit service agencies and businesses in community to post flyers, provide brochures, and gather resources. Use social media, attend community gatherings, and spread the word about the Gospel Justice Center.	Connector, networker, love for community. Outgoing. Loves outreach. Social media gifts. Self-motivated.
 Prayer Champion	You derive joy from prayer. Prayer is energy giving. You discern the Holy Spirit and are led to intervene for others.	Engage host site (church community) in prayer for clients. Complete prayer cards for clients. Pray over the space, team, and clients, and involve others in prayer.	Gift of discernment, prophecy, or faith. Sensitive to Holy Spirit nudges. Encourager.
 Client Intake Specialist	You are the glue that holds the center together. You experience joy knowing this as other team members look to your help in coordinating essential tasks for client scheduling, ensuring high quality client and case documentation, and team administration.	Pre-Center: Organize space, resources, and laptops with WiFi. During Center: Welcome guests, explain process, collect client co-pay, help with registration, and prep for appointment. Post-Center: Restore space, finish documentation and QA, make necessary prep for next center.	Administration. You love to check boxes and ensure smooth efficiency. Technical skills: Organized and good at coordination. Paralegal is helpful but not required. Warm and welcoming.
 Hospitality Specialist	You love making people feel welcome and at ease. You derive joy from providing food and beverage and a safe space for children which puts parents at ease.	Arrange for refreshments and coffee during center times. Set up play areas for children with coloring books, crayons, games, and other small toys. Be available to welcome clients coming into the center.	Gift of hospitality, helps/service, and encouragement. Ability to bless people behind the scenes by creating a welcoming, warm environment.
 Interpreter	You find joy in knowing you are God's bridge of understanding for overwhelmed clients.	Facilitate communication between the client, Attorney, Client Advocate, Client Intake Specialist, and other volunteers as needed.	Bilingual. Professional experience is ideal. Good listener and communicator. Heart of mercy.
 Follow-Up Advocate	Encouraging clients and providing additional care will bless you. Your additional care is critical for clients to follow through on their plan. Hearing results from clients and sharing them with your team will motivate their continued service.	Drive strong client outcomes by following up by call/text/email to help clients work through any barriers they may be facing.	Encourager, gift of helps, mercy or service. Comfortable on phone. Friendly. Able to coordinate information to keep client on track and encouraged.
